#### Dear friends and colleagues:

It has been my privilege to chair a very active Executive Board this year, and I want to thank all of its members for their cooperation and hard work. Over the past year, ASCE has intensified its efforts to expand the discussion and the analysis of Cuban issues worldwide. Starting with the well-attended session on Cuba at the American Economic Association meetings in Philadelphia, to the highly successful Carlos Díaz-Alejandro lecture by U.N. Deputy Secretary-General Ocampo at the Inter-American Development Bank, and to several lectures and seminar on Cuba at the Brookings Institution in Washington, DC. Publication of scholarly pieces on Cuba by members of the Association rarely has been as impressive and voluminous as during the past year: they have ranged from Jorge Sanguinetty's book Cuba—Realidad y Destino to many of the books published by the Institute for Cuban and Cuban American Studies of the University of Miami in the context of its Cuba Transition Project. ASCE is now planning to participate in other meetings, including in Spain and in Puerto-Rico, where its members will continue to present their views on Cuba and to tell the truth as they see it on the difficult problems facing the Island.

A major effort of the Board also has gone into the preparation of this year's Annual Meeting, with Jorge Perez-López acting, as always, as the master conductor. I believe we have an exciting program, with the participation of Egor Gaydar, former Prime Minister of Russia during the early phase of Boris Yeltsin's presidency, and leader of the reforms that sent the cradle of bolshevism on the road to democracy and to a free market economy. We are proud that Mr. Gaydar has accepted our invitation and will be our keynote speaker. We are also happy to present a session on a topic that we consider of primary importance: the relations between Venezuela and Cuba.

Finally, we have stressed, and will continue to stress the importance of bringing to Cuba in a variety of ways the views of ASCE's Board and members. I thank our colleagues in Cuba for the deep interest they have shown in our work and assure them of our continue admiration and support.
