1. First Call for Papers and Session Chairs for the Sixteenth Annual Meeting to be held at the Chapman Conference Center, Wolfson Campus at Miami-Dade College, in Miami, Florida from August 3 to August 5, 2006

ASCE invites papers on subjects related to the Cuban economy and society, including: macroeconomics; banking and finance; agriculture and the sugar industry; tourism; social and political aspects of economic development and transition; education; health; environmental policy; law and legal institutions; privatization; civil society; gender issues; governance; infrastructure; foreign investment, and civil-military relations.

Persons interested in serving as session chairs, discussants or participants in roundtable discussions should also communicate with the Chair of the Program Committee.

2. Annual Student Price Competition. Call for Papers

The ASCE Student Prize Committee appreciates your assistance in promoting our annual **Jorge Pérez-López** Research Award student prize competition. Dr. Enrique S. Pumar (William Paterson University) will chair the committee again this year as in years past, the committee will accept papers from graduate and undergraduate students who analyze the Cuban reality and its repercussions. One of the purposes of this prize is to promote rigorous work on Cuba by students.

Anyone can nominate papers authored by university undergraduate and/or graduate students. The papers can address any topic related to Cuba's domestic issues, its foreign relations, or topics related to Cuba in historical or comparative perspective. Self nominations are also welcomed. All entries must be accompanied by a letter stating the name, mailing address, phone number, and email address of the nominee, and a brief statement describing the merits of the nomination.

For graduate students, the first and second best papers carry awards of \$600 and \$300, respectively. For undergraduate students, the awards for the two best papers are \$300 and 200, respectively. In addition, the first place winners are invited to present their papers at ASCE's 16th annual conference on August 3-5, 2006 in Miami Florida; their papers will be published in Volume 16 of "Cuba in Transition"; and they will be given a travel allowance of up to \$400 each to come to Miami. Additional details are provided in the attached fact sheet and call for papers.

Papers are expected to outline thesis and support it by persuasive evidence. All papers, should be from 15 to 20 pages, and follow one of the standard writing style guides. Papers will be judged by a panel of scholars on the basis of relevance, originality, quality, contribution, and clarity of exposition.

Once again in this year, ASCE members will be asked to elect a new President and a new Board of Directors to carry out the Association's work during the biennium 2006-2008. By April 15, the Secretary of ASCE will provide members with official ballots, instructions, and information about the candidates. Completed ballots are expected to be returned no later than June 15. Votes will be counted and certified by the **Tellers Committee** that will announce the results as soon as possible and submit a formal election report to membership during the annual ASCE Conference in August. The new Board, members will assume their positions in August, after the annual business meeting in Miami.

6. A New Journal on Cuba

"Cuban Affairs," makes its debut on-line this month to academics and Cuba watchers who subscribed to it. The English-language electronic journal's first edition will carry articles on a lively pro-con debate on travel to Cuba, the Cuba/Venezuela connection, Cuba/China connection, Cuba's economic policy, and analysis of Cuba after Castro by Brian Latell, former CIA Director for Latin America and now a Senior Research Associate at ICCAS.

"Cuban Affairs" will also publish book reviews and an updated chronology of events on the island for 2005. ICCAS decided to offer the journal electronically because it provides immediate delivery, more up-to-date articles and a fast way to archive it. The journal will be easy to download, if readers wish to keep a hard copy.

2006 GRADUATE AND UNDERGRATUATE STUDENT PAPER AWARD COMPETITION

The Association for the Study of the Cuban Economy (ASCE) is a nonpolitical, professional international association dedicated to the study of the Cuban economy in its broader political, social, and cultural context.

The Jorge Perez-Lopez Student Award Competition

ASCE Student Award Committee is accepting nominations for the 2006 Jorge Perez-Lopez Student Award Competition. Anyone can nominate original papers authored by undergraduate and graduate students. The papers should address topics related to Cuba's domestic issues, its foreign relations, or Cuba in comparative perspectives. At a minimum, papers are expected to outline a thesis statement and present evidence or data supporting it. All nominations ranging from 20-25 pages must follow one of the standard academic writing and citations styles. Self nominations are also welcomed. All correspondences must be accompanied by a letter stating the name, school affiliation, mailing address, phone number, and email of the nominee as well as a brief statement describing the merits of the nomination.

Graduate Awards

- **First prize** \$600, up to \$400 travel, and publication in *Cuba in Transition*.
- **♣ Second prize** \$300

Undergraduate Awards

- First prize \$300, up to \$400 travel, and publication in *Cuba in Transition*.
- Second prize \$200.

All students who enter the competition will receive a one year complimentary membership in ASCE, which will entitle them to receive our publications and newsletter. If they wish to attend the annual meeting in Miami, they will also receive a complimentary conference and key speaker luncheon invitation (but no travel allowance, except to the first prize winners).

Deadline

Papers received or postdated by **May 20**, 2006 will be considered. The winner of the competition will be announced in June.

Basis for Award

Papers will be judged by a panel of scholars on the basis of relevance, originality, quality, contribution, and clarity of presentation. A 15-20 page limit for the essay will be strictly enforced.
