Dear ASCE member:

I am proud to report that ASCE has been extremely engaged during the late winter and early spring in a number of exciting projects, the most dramatic and rewarding of which has been our co-sponsorship of the US visits of Cuban bloggers and cyber-activists Yoani Sánchez and Orlando Luis Pardo Lazo. ASCE recognizes the generous financial assistance of the Cuba Study Group in allowing us to act as hosts and co-sponsors of these historic visits.

While Sánchez was able participate in our annual conference last August via telephone from Havana, she made her first trip to the United States in March.



ASCE was front-and-center as a cosponsor of "The Revolution Recodified: Social Media and the Public Sphere in Cuba," a three-day symposium held at New York University and the New School in Manhattan from March 15-17. ASCE also co-sponsored a second event, "Cuba and the Digital Revolution" (see photo), that also featured Sánchez and Pardo Lazo on March 20 at Georgetown University with the help of Eusebio Mujal-León, Georgetown's Department of Government, and a number of student groups whom we hope to tap into as future ASCE members! The Georgetown event was followed by a reception for Sánchez and Pardo Lazo hosted by ASCE member Roger Betancourt.

ASCE board member María Werlau also organized a visit for Sánchez to the United Nations on March 21, where she spoke to a gathering of international journalists all members of the United Nations Correspondents' Association. A number of ASCE members were also present at the various public events held with Sánchez upon her historic visit to Miami between April 1-4. Indeed, I worked with the dynamic group of young people who make up *Raices de Esperanza* (Roots of Hope) pull off the hour-long "Tweet-Up" held on April 3 at downtown Miami's Adrienne Arsht Center for the Performing Arts.

In other news related to social media, ASCE has decided to launch its very own blog, a project headed up by Luis Luis and Ernesto Hernández-Catá. Preparations are well underway for ASCE's annual conference, this year's title is "Reforming Cuba?" (http://www.ascecuba.org/conference/info/).
